28 **PLAINTIFFS' SECOND SUPPLEMENTAL
REPORT REGARDING STATUS OF
CLAIMS ADMINISTRATION AND
DISTRIBUTION OF SETTLEMENT
FUNDS**

29 Class counsel provide the Court with this further update concerning the distribution of
30 settlement proceeds. The claims administrator plans to make an initial distribution on Monday,
31 July 9, 2018 to the more than 10,000 class members. A letter will accompany this distribution
32 informing the class members that this is the first of two distributions and is approximately half of
33 their total distribution. The letter will also identify the class member's "work state" for tax

1 purposes, pursuant to the data provided to the claims administrator by Defendants, and provide
 2 instructions on how to correct the work state by July 31, 2018 if it is not correct. The second
 3 distribution with the remaining proceeds will be made in August 2018 and will include the tax
 4 documents (e.g., Form W-2 and Form 1099), reflecting any updated work state. The claims
 5 administrator believes that proceeding with a single distribution now would result in using the
 6 wrong work states for a significant number of class members, which would require them to file a
 7 tax return in a state other than their correct work state. By engaging in this two-step distribution,
 8 the claims administrator can address a concern over incomplete and/or inaccurate work state data
 9 from Defendants and allow class members the opportunity to correct the work state before the
 10 final distribution is made.

 13 The claims administrator has posted this update to the case website and further
 14 instructions for class members on how to ensure their work states are accurate.
