DISTRIBUTION OF SETTLEMENT

1 Class counsel provide the Court with this fourth update concerning the distribution of
2 settlement proceeds.

3 All funds have now been distributed, except for any remaining cy pres funds. On
4 September 19, 2018, the claims administrator distributed the second (and last) round of payments.
5 The following chart from the claims administrator provides an update on the status of the checks
6 mailed in the first distribution, and shows that 81% of all checks in the first distribution have been
7 cashed to date, which constitutes 91.5% of all funds in the first distribution:

16 which constitutes 66% of all funds in the second distribution:

21 Overall, approximately 68% of all checks have been cashed, comprising 77.5% of all
22 funds. Of the 513 undelivered checks from the first distribution, 133 have been reissued, and 86
23 have been cashed to date, totaling \$401,293.58.

24 The claims administrator will post this update to the case website to inform class members
25 that all funds have been distributed. In addition, class counsel will submit a further update with
26 post-distribution data “within a week after distribution of both the settlement fund and any cy pres
27
